

### Fund commentary

Global share markets rose in local currency terms in November but were lower in unhedged AUD terms, with the MSCI World Index net closing the month down 1.8%. In hedged AUD terms the index returned 1.1%. The gains were driven in large part by some surprisingly dovish comments from US Federal Reserve chairman, Jerome Powell, who conceded that interest rates are now close to neutral. Investors interpreted the comments to mean the pace of rate hikes next year may be slower than previously anticipated. Australian shares fell in November; the S&P/ASX 300 Accumulation Index falling 2.2% amid weakness across the major miners, mixed returns from the 'Big Four' banks and yet another tepid inflation reading. Elsewhere, global bonds posted modest gains, with the Bloomberg Barclays Global Aggregate Bond Index returning 0.4% in hedged AUD terms. Australian bonds were also positive for the month, with the Bloomberg AusBond Composite 0+ Year Index returning 0.2%, while the domestic cash market also returned 0.2%.
