# Change of investment manager Ellerston Australian Market Neutral Fund

**Dear Investor** 

We wish to inform you of a change to the investment manager and name of the above mentioned investment option.

Generation Life continually reviews its investment options and investment managers. Following a review of the Ellerston Australian Market Neutral Fund (Fund code - UF6A), we have decided that in order to better meet the objectives of the investment option, a change to the investment manager is appropriate.

As a result, the investment option's investment management will be moved from Ellerston Capital to Firetrail Investments (Firetrail) to better meet the investment option's objectives.

### New investment strategy

The investment option's investment strategy will change as a result, and the investment option's name will also change to the Firetrail Absolute Return Fund effective from 28 April 2021. Please refer to the enclosed flyer for more information on the updated investment option.
