## Investment objective

Aims to provide long-term tax effective total returns, with diversification across a broad range of Australian companies and industries.

## Investment approach

The fund uses a systematic quantitative rules-based approach to build a diversified portfolio by considering factors such as the quality of a company, its growth potential and its implied value relative to its price. The approach considers the tax position of each holding and incorporates additional active investment insights to take advantage of dividends, associated franking credits and other tax effective payments with the aim of delivering an enhanced after-tax return.

## Performance commentary

For the one-month period ending 31 October 2021 the after fee and tax return was -0.28%.

Industrials, Consumer Discretionary and Energy sectors were the largest contributors to active return during the month.

By contrast, allocation in Communication Services, Information Technology and Consumer Staples were the largest detractors for the month.

At a stock level Gold Road Resources Ltd, Challenger Ltd and JB Hi-Fi Ltd were the top contributors. On the other side, positions in Domino's Pizza Enterprises, Mineral Resources Ltd and Aurizon Holdings Ltd detracted from returns.

The rolling 12-month cash dividend yield of the fund is forecast to be 3.91% versus the S&P/ASX200 Index of 3.78%.

## Market commentary

The Australian equity market (S&P/ASX 200 Accumulation Index) fell by a modest -0.1% over the month of October. Optimism over the re-opening of the country from lockdown improved the market outlook, however, talk of potential interest rate rises dampened markets, resulting in a relatively flat outcome over the month.

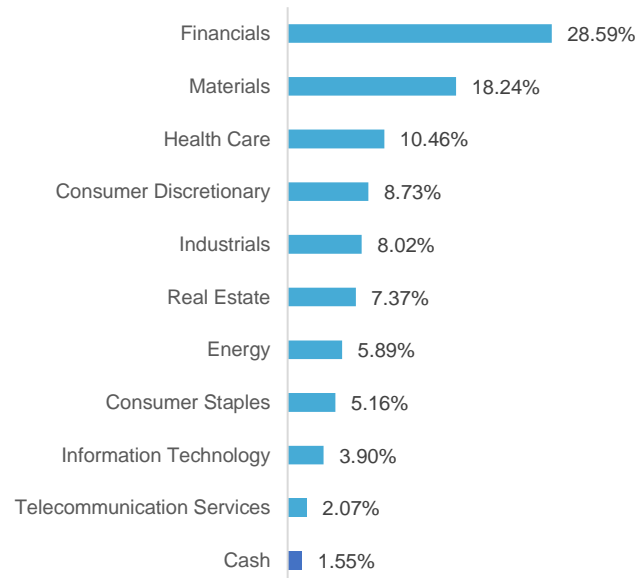
Sector wise, the best performer was Information technology (+2.1%) while Healthcare (+1.0%) and Financials (+0.8%) sectors also performed well.

Industrials (-3.3%) was the worst performing sector, while Consumer Staples (-2.3%) and Energy (-2.7%) also fell in October.
