The following table shows the additional tax alpha generated through Generation Life's tax management process across the range of investment options available through the LifeBuilder, ChildBuilder and FuneralBond products.

Returns shown are after all fees and taxes for the financial year ended 30 June 2024. The actual returns relating to the investment options will be influenced by the timing of payments into and out of the investment, allowing for contributions, taxes, fees, switches between investment options and withdrawals.

Tax alpha is determined as the excess return generated when compared to the same investment option being held through the Generation Life investment structure with no tax aware management process implemented. The tax alpha measures the additional benefit that the tax aware process provides compared to a standard investment bond tax management process.
