# Investment objective

Aims to provide long-term tax effective total returns, with diversification across a broad range of Australian companies and industries.

# Investment approach

The fund uses a systematic quantitative rules-based approach to build a diversified portfolio by considering factors such as the quality of a company, its growth potential and its implied value relative to its price. The approach considers the tax position of each holding and incorporates additional active investment insights to take advantage of dividends, associated franking credits and other tax effective payments with the aim of delivering an enhanced after-tax return.

### Performance commentary

For the one-month period ending 30 April 2025 the after fee and tax return was 3.70%.

The fund primarily benefitted from strong stock selection and notably being underweight Woodside Energy Group which fell by 10% over the month. Sector exposures has a relatively small impact on active returns over the month with the Fund benefitting from a modest underweight position in Energy and Materials sectors.

# Market commentary

The Australian equity market (S&P/ASX 200 Accumulation Index) returned 3.62% over the month of April 2025.


Over April, the strongest gains were made in Technology and domestically oriented retailers who were likely beneficiaries of US tariffs on China. Interest rate sensitive sectors such as Financials and Real Estate also saw gains. The Energy sector weighed on the local bourse on the back of lower oil prices.
