Investment objective

The fund aims to provide long-term tax effective total returns, which track the performance of the MSCI World Index (AUD) before fees and tax

Investment approach

The fund uses a systematic quantitative rules-based approach to build a diversified portfolio by considering factors such as the quality of a company, its growth potential and its implied value relative to its price. The approach considers the tax position of each holding and incorporates additional active investment insights to take advantage of dividends, associated foreign tax credits and other tax effective payments with the aim of delivering an enhanced after-tax return.

Performance commentary

For the one-month period ending 30 September 2025 the after fee and tax return was 2.28%.

Sector performance was broadly positive, with information technology and Industrials continuing to benefit.

Market commentary

Global equities advanced in September, with large-cap stocks outperforming their smaller counterparts. In the US, markets posted strong gains, buoyed by a widely anticipated Federal Reserve rate cut and signals of further monetary easing for the remainder of the year. However, sentiment was tempered by renewed tariff announcements and concerns over a potential government shutdown.

European equities also recorded another positive month, reaching new highs on the back of solid earnings, despite mixed economic data. UK equities closed higher, supported by an improved global economic outlook that helped lift investor confidence.


In the Asia-Pacific region, equities rose, led by notable gains in Taiwan and Korea. Chinese markets advanced, driven by strength in the technology and energy sectors, with sentiment improving amid signs of easing US - China trade tensions. While a meeting between Presidents Trump and Xi remains unlikely until 2026, the prospect of renewed dialogue contributed to a more constructive tone across regional markets.
