### Investment objective

Aims to provide long-term tax effective total returns, with diversification across a broad range of Australian companies and industries.

## Investment approach

The fund uses a systematic quantitative rules-based approach to build a diversified portfolio by considering factors such as the quality of a company, its growth potential and its implied value relative to its price. The approach considers the tax position of each holding and incorporates additional active investment insights to take advantage of dividends, associated franking credits and other tax effective payments with the aim of delivering an enhanced after-tax return.

#### Performance commentary

For the one-month period ending 31 October 2025 the after fee and tax return was 0%.

Performance trailed the benchmark slightly largely as a function of stock selection within Financials and Health Care sectors. The performance of the underlying factors was relatively muted over the course of the month as investor sentiment focussed on macro drivers.

#### Market commentary

October saw continued positive momentum in Australian equity markets, with the S&P/ASX 300 Accumulation Index posting a gain of 0.4%. Elevated inflation readings prompted central banks to maintain current interest rates, rather than implement cuts. Nevertheless, ongoing economic growth and other constructive developments have supported market performance.

From a Sector perspective, The Materials and Energy sectors have demonstrated renewed strength in recent months, reflecting increased cyclicality from improving economic conditions and favorable trends in key commodities essential to national security. The critical minerals segment also advanced, following the announcement of a new framework between Australia and the United States in October, which focuses on investment in processing, critical minerals, and rare earths.


