Investment objective

Aims to provide capital appreciation over the longer term by investing in a concentrated portfolio of global shares and aims to outperform the MSCI World Index (with net dividends reinvested) unhedged, measured in AUD over a full market cycle, before taking into account investment fees, expenses and tax.

Investment approach

In selecting investments in the portfolio, the manager is not constrained by any particular investment style. The manager may invest in the stocks of companies it believes to have above average earnings growth potential compared to other companies (growth companies), in the stocks of companies it believes are undervalued compared to their perceived worth (value companies), or in a combination of growth and value companies.

The manager uses an active bottom-up investment approach to buying and selling investments. Investments are selected primarily based on fundamental analysis of individual issuers and their potential in light of their financial condition, and market, economic, political and regulatory conditions. Factors considered may include analysis of an issuer's earnings, cash flows, competitive position and management ability. Currency hedging is rare and usually only undertaken for defensive purposes and as part of the security selection process. The portfolio does not systematically employ currency management techniques and is considered to be unhedged.
